MEMORANDUM OF ASSOCIATION

1. NAME OF SOCIETY : Nav Yuva Shiksha Samiti
2. REGISTERED OFFICE : Vill. Asalwas Dubia, P.O Asalwas Marhta, Distt. Bhiwani
3. JURIDICTION : The. Society shall work within the territory of State of Haryana.

4. AIMS, OBJECTIVES OF THE SOCIETY

The objectives, which are specific to a society, shall be enumerated below. Some of the indicative objectives could be as under

- a) To Manage the Educational Institution run by the above Society.
- b) To arrange facilities for good quality, basic and higher Education (Shaksharta) in general and the poor students in particulars.
- c) To promote the Swadeshi Culture through Education with special emphasis on mutual cooperation and brotherhood.
- d) To work for the removal of social evils such as untouchability, illiteracy and inferiority complex among the students from their childhood.
- e) To promote Institutions to impart Technical, Medical Education and Physical Training and Yoga Training etc.
- f) To work for the batterment and welfare of staff and students of the educational institution run by the above educational Society and to manage the scholarships and Educational Schemes.
- g) To provide suitable accomodation to Educational Institutions and make necessary adjustment, constructions, alteerations and maintainance etc. in the building.
- h) To purchase, take on lease or in exchange, hire or otherwise acquire property necessary or convenience for the purpose of the society, and to improve develop, manage, sell lease, mortgage, dispose or turn to account or otherwise deal with all or any part of the property of the society.

- i) To raise funds by subscriptions, donations and grants from any person or persons, private or public trusts, public bodies and the State Govt, Central Govt, or Govt. undertaking and arrange payment for services rendered and to utilize invest or spend the same as decided by executive committee of the society from time to time.

5. CONDITIONS

- a) The income and property of the society shall be applied solely towards the promotion of the objects of the society as set forth in the Memorandum of Association and no portion thereof shall be paid or transferred directly or indirectly or indirectly, to the members of the Society.
- b) No member of the society, shall be appointed to any salaried office of the Society, or any office of the Society paid by fees, that no remuneration shall be given by the society to any member of the society except repayment of out of pocket expenses and interest on money lent or rent for premises/demised to the Society.
- c) The Society by its constitution is required to apply its profits, if any, or other income in promoting its objects.
- d) If upon the winding up or dissolution of the society there remain after satisfaction of all debts and Liabilities any property whatever, the same shall not be paid to be or distributed among the member of the society, but shall be given or transferred to some other institution having objects similar to the objects of the society to be determined at or before the time of dissolution.
- e) That society will solve their problems or disputes on their level and Distt. Registrar Firm & Society will be no involvement in that case.
